BEC Submission on the Public Consultation for the 2018-19 Budget



As Hong Kong's leading business membership organisation focused on environmental sustainability, BEC actively contributes policy recommendations to the HKSAR Government. To follow up on our policy submission for the Chief Executive's Policy Address October 2017, BEC has recently made another submission to the Government in relation to its 2018-19 Budget.

We made recommendations as to how the Government can incentivise and ramp up investment as to the following:

- Transitioning to a low emission transport and logistics sector to improve air quality and reduce carbon emissions
- · Improving energy efficiency of commercial buildings to reduce carbon and saving costs
- Support the climate change 4Ts Charter that involves businesses setting carbon reduction target-setting
- Enhanced waste management systems in line with a circular approach to resource use.

SWIRE PROPERTIES

BEC Council Member Swire Properties successfully issued their first green bond in January 2018, raising US\$500 million at a coupon rate of 3.5%, due 2028. The 10-year green bond is the first in Hong Kong to obtain pre-issuance stage certification under the newly launched Green Finance Certification Scheme by the Hong Kong Quality Assurance Agency (HKQAA). The net proceeds from the green bond will be used to fund or refinance the Company's new or existing green projects that relate to green building development, energy efficiency, renewable energy, sustainable water and wastewater management, or climate change adaptation.

BEC Corporate Member NWS Holdings' flagship community campaign, "NWS Hong Kong Geo Wonders Hike", includes a green race "NWS Geo Hero Run" to promote geoconservation and wellness. In 2017, the running event continued to champion environmental protection by adopting additional measures to reduce waste. These included using recyclable and reusable cups to replace disposable paper cups at water stations, distributing electronic runner guides instead of print, and partnering with green groups on waste recycling. The "paperless" initiatives saved some 10,000 paper cups and 50,000 pieces of A4 printing papers.
