# **BEC ENVIROSERIES CONFERENCE**

BEC held its flagship EnviroSeries Conference online on 27 November. Entitled "Urban Transport on the Move: Connecting Policies, People and Business Opportunities", the Conference attracted over 400 business leaders, entrepreneurs, industry experts and academics from different time zones to explore how the urban transport system of the future can be carbon neutral, people-centric and supportive of a sustainable living environment.

BEC Chairman Mr Richard Lancaster acknowledged that transport and city planning are interconnected. In the midst of the challenges we are facing due to COVID-19, climate change and other environmental issues, we should aspire to build not just a carbon-neutral and resilient, but also liveable, healthy, active and happy Hong Kong.

Key takeaways from each session:



#### Session 1:

#### Planning for a Sustainable and People-centric Urban Transport System

- Private car ownership has been growing at a rate higher than the increase of the total length of public roads and the population size in Hong Kong; this calls for the need to control the number of private vehicles.
- The priority for urban and transport planning is gradually shifting from car-centric designs to humancentric designs.
- With transit-oriented development fully ingrained in Hong Kong's urban landscape and extremely high public transport utilisation rate, town planners should focus on the promotion of active and non-mechanised transport for the first and last mile of public transport journeys.







#### Session 2: **Future Private Mobility and Public Transport**

- Under COVID-19, the use of private transport has gone up at the expense of public transport due to people's health concerns. However, studies actually show that public transport is often cleaner and safer than what travellers perceive.
- Tailpipe emission reduction should not be the only consideration when it comes to improving air quality and decarbonisation; the emissions resulting from traffic congestion and power generation also need to be taken into account.



#### Session 3:

#### **Business Innovation and Opportunities in Post-COVID-19 Urban Mobility**

Smart mobility infrastructure like smart corridors improve safety and efficiency, and can also provide users with accurate and reliable data to better plan their journeys.

New forms of smart mobility like on-demand transportation, new energy cars, and connected and automated vehicles are on the rise. To better integrate them into our wider transport system, we need to consider our energy system and end-user needs, and examine how we can encourage data sharing and pilot testing.





#### Session 4: **Promoting Active and Inclusive Transport**



- There is a need to rehumanise streets to make them more people-centric. Although Hong Kong has a robust pedestrian system, the quality of the walking experience needs to be improved, through investing and improving access to public spaces and urban parks.
- Benchmarking and monitoring what happens on the ground is crucial for evidence-based policy. For example, smart sensors can be used to measure streetlevel air pollution or commuting patterns.
- There is a strong business case for promoting walking. Along with connectivity, tenants, users, customers and the wider public are expecting more such as convenience and an enjoyable experience.

### **BEC Policy Dialogue Series: The Chief Executive's 2020 Policy Address**

We are pleased to have hosted Under Secretary for the Environment Mr C.W. Tse at the BEC Policy Dialogue Series on 15 December to provide our members with an overview of the ongoing and new initiatives relating to environmental protection and sustainable development covered in the recent Policy Address. Mr Tse also engaged in a dialogue with BEC Chairman Mr Richard Lancaster and Deputy Chairman Dr Eric Chong and responded to questions from the online audience.



BEC welcomes the HKSAR Government's pledge to achieve carbon neutrality by 2050, announced in this year's Policy Address. We have long been advocating the need for the Government to demonstrate climate leadership and commitment, and to set a science-based, absolute carbon reduction target for Hong Kong with a clear roadmap and critical milestones. In recent years, BEC members and the wider business community have demonstrated determination and resolve to decarbonise and to enhance their long-term business sustainability and resilience in the wake of the climate emergency. As details of the Hong Kong Climate Action Plan unfold next year, BEC will engage members on the proposed government strategies and provide constructive feedback to the Administration to shape Hong Kong's transition to a carbon neutral economy which is competitive and resilient.

#### **Eco Asia Conference**

As part of the 15th Eco Expo Asia, BEC co-organised the Eco Asia Conference focused on the circular economy on 20 November. BEC's Director – Development Mr C.W. Cheung moderated a session on how we can move away from the "take, make, use and dispose" model referencing circularity cases in fashion and plastic.

#### The Swedish Model for a Green Recovery – Emerging Stronger and Better Post-COVID-19

BEC's Director - Policy & Research Mr Simon Ng joined "The Swedish Model for a Green Recovery – Emerging Stronger and Better Post-COVID-19" panel discussion organised by the Swedish Chamber of Commerce in Hong Kong on 3 December. He mentioned that our planet has spoken loud and clear that we are on an unsustainable pathway. Post-pandemic recovery should focus on green stimuli that enable a sustainable, inclusive and resilient economy and society.



Mr Ng previously shared his thoughts on the post COVID-19 recovery in the September issue of The Bulletin, the Hong Kong General Chamber of Commerce magazine. In the article, he cited plans and initiatives from overseas which are working to "build back better" and urged the Hong Kong SAR Government and local businesses to follow suit in their recovery plans.

### **Designing Buildings for A Zero Waste Hong Kong**



Close to 200 participants from Hong Kong and around the world tuned into BEC's webinar "Designing Buildings for a Zero Waste Hong Kong" on 8 December. Co-organised with the Center for Zero Waste Design from New York City, Founder Ms Clare Miflin delivered a keynote presentation on the development of Zero Waste Design Guidelines in New York City and how the same approach can be adopted by high-density cities like Hong Kong. This includes the principle of equal convenience - where trash and recycling bins should be equally accessible to avoid building users putting recyclables in trash bins out of convenience.



Our panellists then shared insights on current waste management challenges in Hong Kong and discussed potential actions that can be taken by architects, designers, financial institutions and other key stakeholders. They also suggested a few actions for the way forward:

- review and update existing regulations relating to refuse room requirements;
- provide incentives for developers, building owners and users to reduce waste;
- raise stakeholder awareness along the building and construction value chain.

### Decarbonising the Shipping Sector and the Potential Role of LNG in Hong Kong



In the Report on the Public Engagement on Long-term Decarbonisation Strategy prepared by the Council for Sustainable Development, Liquefied Natural Gas (LNG) is considered an interim low-carbon energy option while we continue to explore other long-term zero-carbon solutions. It is playing an increasing role in shipping and road transportation as an alternative to diesel and petrol across the world, and there are opportunities to further extend LNG use in Hong Kong. In view of this, BEC held a webinar on 17 December on "Decarbonising the Shipping Sector and the Potential Role of LNG in Hong Kong", which attracted 130 participants online.



Key points that were raised:

- While LNG is not the perfect solution to achieve zero carbon emissions, it is a proven and readily available option today for ships. An early transition to LNG can reduce accumulated carbon emissions while the shipping industry is waiting for alternative zero carbon fuel technologies to become market ready.
- Infrastructure will be in place after the offshore LNG terminal becomes operational in Hong Kong. Providing ship-to-ship LNG bunkering for ocean-going vessels will not only reduce carbon emissions, but also cement Hong Kong's position as a bunkering port in the region and maintain the port's competitive edge in the future.

#### **Council Members**

Airport Authority Hong Kong (AAHK) received the Silver Award under the Organisations Category and Excellent Award under the Industry Practitioners Category in the Construction Industry Council (CIC) Sustainable Construction Award for its three-runway system (3RS) Deep Cement Mixing (DCM) works. This is the first marine DCM project in Hong Kong and the world's largest application of DCM in a single project.

Chinachem's LEED Platinum-certified commercial building One Hennessy and agefriendly residential development at Anderson Road are featured in the triennial Hong Kong Report on the State of Sustainable Built Environment co-published by the Construction Industry Council and Hong Kong Green Building Council. Released at the renowned World Sustainable Built Environment Online Conference 2020, the Report showcases these two developments as being among Hong Kong's top-notch sustainable building projects. They also demonstrate the Group's strong commitment to sustainability and efforts in shaping a more liveable Hong Kong.



Sun Hung Kai Properties (SHKP) accomplished its five-year target to reduce by 10% electricity consumption intensity of buildings managed by its Energy Optimization Committee (EOC) by fiscal year 2019/20 from the 2014/15 baseline. To achieve this target, SHKP adopted a host of measures including carrying out retro-commissioning, testing nano-coating on glass curtain walls, providing free energy audits and technical energy advice to tenants and introducing digital solutions to promote building sustainability. To replicate these results, the Group commits to further reducing the electricity consumption intensity of EOC-managed buildings by 13% by fiscal year 2029/30 compared to 2019/20.
