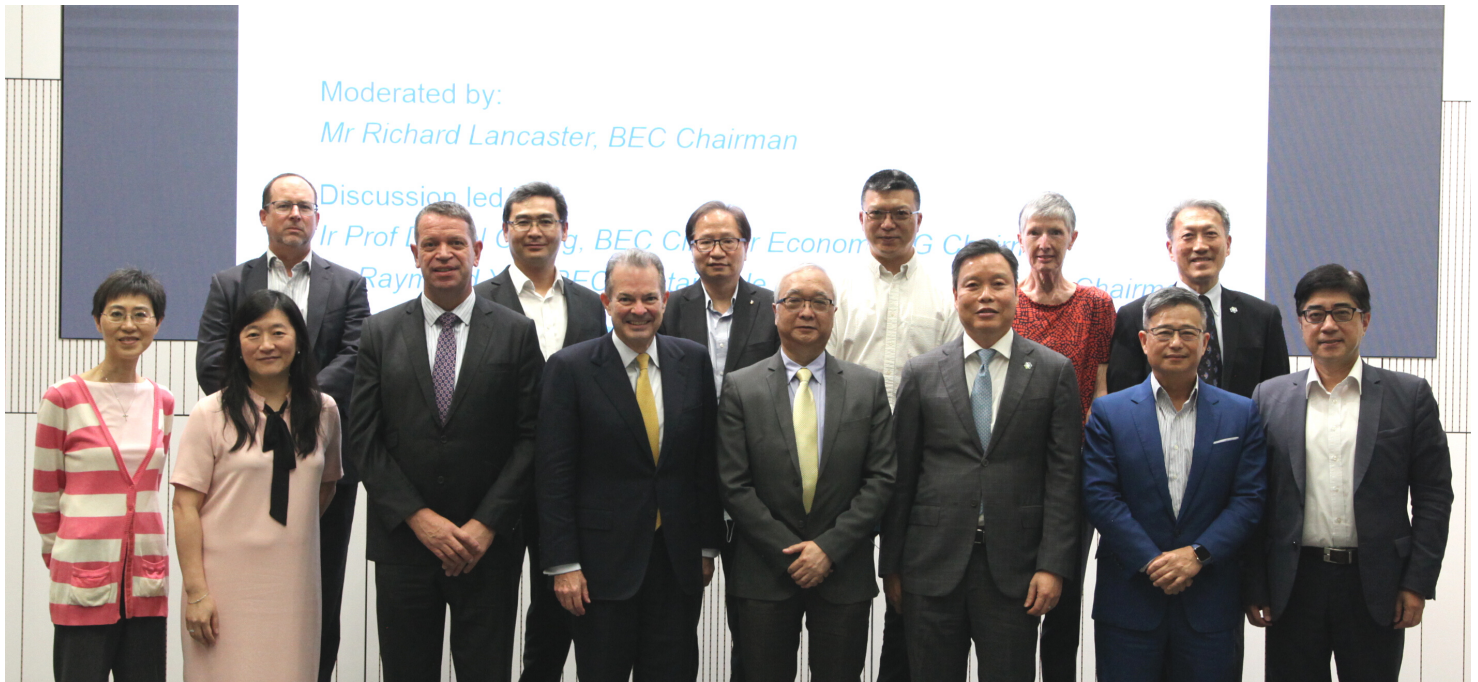

## SUMMER MEET-UP WITH ENVIRONMENT BUREAU

Providing input to help the Government shape policy is one of the key attributes of BEC. BEC Board of Directors met with **Mr C.W. Tse, Under Secretary for the Environment** in the annual Summer Meet-up on 23 June to exchange views on the Government’s planned policies and on BEC’s suggested input around our three environmental focus areas, namely **climate change, circular economy, and sustainable living environment**.

The outcome of the meet-up will facilitate preparation of BEC's submission on the Chief Executive’s 2020 Policy Address. The draft submission will be circulated among BEC members for inputs in July before submitting to the Government around end August.

BEC Council Member **Modern Terminals Limited** is honoured to receive the Silver Award in the Transport and Logistics category of 2019 Hong Kong Awards for Environmental Excellence. The Company's recent key achievements include reaching the ten-year emission reduction target by reducing its emission intensity by more than 30% to less than 10kg per TEU, conversion of diesel-powered rubber-tyred gantry cranes (RTGs) to electricity-powered ones, and LED light replacement on quay cranes and RTGs. Modern Terminals is also proud to have the first pure electric-driven tractor in Hong Kong operating at its Hong Kong facilities. As another milestone achievement, DaChan Bay Terminals has become the first container terminal in South China with all berths featuring shore power capability.

## BEC MEMBERS CORNER



Manufactured domestically from used cooking oil and grease trap oil, biodiesel is a renewable fuel recognised as an alternative to fossil fuel. BEC Council Member **Shell Hong Kong Limited** recently collaborated with The Chinese University of Hong Kong (CUHK) and introduced Shell's FuelSave B5 Diesel, which contains up to 5% of biodiesel and contributes to lowering well-to-wheel CO<sub>2</sub> emissions and maintaining engine efficiency of all campus vehicles. Formulated with Shell's advanced dual detergent DYNAFLEX Technology, the diesel helps reduce CO<sub>2</sub> and black smoke emissions, as well as solving the long-standing problem of sudden breakdown of the vehicles. As reflected by CUHK, following the use of biodiesel, they are now striving to optimise their fleet operations, so as to pave ways for a cleaner campus environment.

BEC Council Member **The Hong Kong and China Gas Company Limited (Towngas)** supports the long-term decarbonisation strategy in Hong Kong through the application of different kinds of renewable energy. In this connection, Towngas has recently installed solar panels in Tai Po Gas Production Plant and 6 offtakes and pigging stations. It will continue the installation of solar panels in its North Point Headquarters and additional innovative technologies such as bifacial panels and sun trackers will be further explored. By the end of 2020, approximately 300kW solar photovoltaic (PV) systems should have been installed, which can generate over 300,000 kWh of clean energy per annum.

### FUNG GROUP

BEC Corporate Member **Fung Group** is committed to managing resources responsibly and contributing to a circular economy, while constantly taking action to improve recycling rates within its operations and plastic hanger recycling is one of these initiatives. LF Logistics and Circle K, business units under Fung Group, are partnering with other retailers to collect plastic wraps, carton boxes, and plastic hangers for recycling. Over 11.5 tonnes of plastics and cardboard waste have been diverted from landfills since the beginning of April 2020, and over 1.7 tonnes of plastic hangers were reclaimed from the customers' warehouses in 4 weeks. Study shows that reclaiming a hanger reduces carbon emissions by a minimum of 80% compared to manufacturing a new hanger with plastic. Fung Group aims to minimise the amount of waste and reuses materials as future resources. Other recycling programmes within the group include the recovery of edible food and waste and cosmetics packaging.

BEC Corporate Member **Hong Kong Air Cargo Terminals Limited (Hactl)** places utmost importance on combating climate change, implementing measures such as setting up solar panels and retrofitting lights to LED. As a result, Hactl has reduced its total carbon emission by 21% from 2015 to 2019. To show its commitment to carbon reduction, Hactl has officially signed the Low Carbon Charter launched by BEC. By signing the Charter, Hactl can strengthen its connection with other signatories and collaborate in future carbon reduction journey.

Data in May 2020 show that in the past year, Cornerstone's RVMs have collected more than 1.9 million PET#1 bottles for recycling, preventing them from being dumped into the landfills directly. Recycle and reward schemes, along with advanced recycling technology, have greatly raised the awareness in waste reduction at source among consumers. Public participation in technological innovation has spontaneously been changing consumers' behaviour, intention and habits in recycling.
