## Post-COP27 Dialogue on Green Business Opportunities between Suez Canal Economic Zone and Hong Kong

On 29 May, BEC and Invest Hong Kong co-hosted the Post-COP27 Dialogue on Green Business Opportunities between Suez Canal Economic Zone and Hong Kong. InvestHK Head of Consulate and Chamber Engagement Mr K.C. Lam kicked off the dialogue, followed by openings by CG Mr Baher Sheweikhi from Consulate-General of Egypt in Hong Kong and BEC CEO Mr Simon Ng.

During the meeting, Mr Waleid Gamal Eldien, MSc, Chairman of Suez Canal Economic Zone ("SCZONE"), introduced the business opportunities in SCZONE and Egypt like green fuel (e.g. green hydrogen), bunkering, data



centres, water desalination, solar photovoltaics and wind turbines, as well as the incentives for investors within the economic zone. In addition, BEC Members shared their views on the potential business opportunities between SCZONE and Hong Kong.

SCZONE is located around the international maritime route "Suze Canal passageway", which connects Europe, East and North Africa via the Suez Canal with Asia, passing through the Arabian Gulf and serving the majority of global trade.

## **ESG CORNER**

#### BEC welcomes ISSB's issuance of inaugural sustainability standards

The ESG community around the globe has recently welcomed some exciting news!

The International Sustainability Standards Board ("ISSB") issued the long-awaited inaugural sustainability standards, International Financial Reporting Standards ("IFRS") S1 General Requirements for Disclosure of Sustainability-related Financial Information and IFRS S2 Climate-related Disclosures on 26 June 2023. Although these standards are currently voluntary, the ground-breaking initiative has set the first-ever global sustainability standards in alignment with accounting principles across the capital markets in different countries. Also related to the newly launched standards, The Stock Exchange of Hong Kong ("HKEX") published a <u>consultation paper</u> seeking feedback on proposals to enhance climate-related disclosures under the ESG framework. It is understood that HKEX is proposing to mandate all issuers to make climate-related disclosures in their ESG reports and introduce new climate-related disclosures aligned with the ISSB Climate Standard. Airport Authority Hong Kong ("AAHK") successfully held the HKIA Carbon Management Senior Executive Roundtable on 6 June, bringing together 29 key business partners who have joined the HKIA 2050 Net Zero Carbon Pledge. Under the theme of "the importance of green recovery for the aviation sector", Mr Fred Lam, CEO of AAHK, delivered opening remarks. He highlighted AAHK's recent efforts to support business partners in reducing carbon emissions through the HKIA Business Partner Carbon Support Programme. The Guest of Honour, Mr Tse Chinwan, Secretary for Environment and Ecology, delivered a keynote speech outlining the Government's plan to achieve carbon neutrality by 2050. Another speaker, Mr Simon Ng, CEO of BEC, emphasised the importance of collaboration to achieve green recovery and transition towards net zero.



Hang Lung Properties deepens collaboration with the Hang Lung Center for Real Estate at Tsinghua University on industry-university work in the field of sustainability, proptech innovations, and exceptional talent cultivation. The company has also initiated a "Sustainable Real Estate Scheme" for the university's teachers and postgraduates. The scheme provides funding for their creative academic research on topics including green buildings, healthy buildings, lowcarbon development and digitalisation, with the goal to advance sustainability for commercial and mixed-use developments and the cultivation of talent.

**Shell** is committed to integrating the concept of sustainability into its business and striving to become a net-zero emissions energy business by 2050. In March 2023, Shell Hong Kong installed a solar power generation system with a 9-kW power generation capacity at the Airport (Cargo Terminal) Gas and Charging Station, becoming the first gas station in Hong Kong to have a solar power generation system. The system has a total area of about 50 square metres and is connected to the fellow BEC member CLP's power network, which is expected to generate 10,000 kWh of electricity per year, equivalent to reducing carbon emissions by 5.5 tonnes.



To accelerate digital and net-zero transformations for a greener tomorrow, **Siemens** hosted Siemens Innovation Forum 2023 on 27 June. Co-organised with BEC and supported by Invest Hong Kong and German Industry and Commerce Ltd. Hong Kong, the forum consisted of insightful presentations and discussions from prominent speakers, a tech exhibition, as well as a networking session to unlock digital potential and revolutionise the path to net zero. Gathering business leaders, industry experts, and academia, the forum served as a breeding ground to create an ecosystem of innovation and envision a more sustainable future powered by digital transformation.

Swire Properties celebrates 15 years of fruitful collaboration with Tsinghua University at the partnership renewal ceremony for the Joint Research Centre for Building Energy Efficiency and Sustainability held in April 2023. This is the third agreement renewal for the Tsinghua University – Swire Properties Joint Research Centre, with the fourth phase of the research running between April 2023 and April 2026. Swire Properties has committed to invest RMB 15 million funding for the Joint Research Centre, with a focus on researching energy saving and decarbonisation technologies to combat climate change and to contribute to the decarbonisation goals of Hong Kong and the Chinese mainland. This successful partnership has demonstrated its ability to develop advanced decarbonisation technologies and various innovative solutions that enhance integrated building design and whole process management, pushing the limits and transforming conventional building management. A notable achievement is the Cloud-Based Smart Energy Management Platform, which received the Best Digital Innovation Award at the 2023 Building Performance Awards organised by CIBSE.

**Towngas** has set up Hong Kong's first hydrogen extraction system using "pressure swing adsorption technology" to extract hydrogen from its gas network with a purity of up to 99.99%. The hydrogen can be distributed to customers through the company's existing underground pipeline network covering the entire Hong Kong, providing a cost-effective, safe, and efficient hydrogen energy solution. Hydrogen energy can be applied to a wide range of transport modes, such as buses, heavy vehicles, ships and railways. Specific plan on promoting the implementation of hydrogen energy technology in Hong Kong will be announced in the second half of 2023 to actively support China's 30-60 dual carbon goals and Hong Kong's 2050 carbon neutrality strategy. **Click here to learn more**

**CLPe** joins hands with a leading international car rental company in Hong Kong to launch Hong Kong's first "Electric Vehicles as a Service", a one-stop electric vehicle ("EV") rental and charging service that offers cost-effective solutions for businesses to switch to green motoring and help Hong Kong achieve its goal of zero vehicle emissions. CLPe will customise charging solutions, and fund, procure and install the EV charging facilities for businesses based on their needs. Customers will only need to pay a monthly fee covering EV rental payment inclusive of vehicle registration fee, licensing fee and insurance, and charging services fees. Other value-added services and benefits such as mobile app and cloud management platform will be provided for businesses to manage their fleets.



FUJIFILM BI HK has recently participated in the physical walkathon "Walk for Living Water" in response to United Nation's World Water Day. The company's Volunteer Team walked while carrying water buckets to experience the hardship of fetching water, with the aim of raising funds for water-deprived communities to establish clean water supply and sanitation facilities. Improving effective use of water resources is one of Fujifilm Group's top environmental concerns. The company is committed to reducing water use and improving water recycling across the entire product lifecycle, while contributing to water treatment through its products and services within the set targets.

The **Great Eagle Group** recently launched two sustainability-related undergraduate scholarship programmes with fellow BEC members The Hong Kong University of Science and Technology ("HKUST") and City University of Hong Kong ("CityU"), aiming to nurture local talent in the fields of sustainable development, environmental management and energy science. Forty Great Eagle Group Scholarships of HK\$25,000 each will be given out at each university in the coming years – a total of HK\$2 million – to support students at the Division of Environment and Sustainability at HKUST and the School of Energy and Environment at CityU. The scholarships reflect the group's commitment to cultivating talent and giving young people opportunities to develop their potential and shape a sustainable future.



In preparation for Hong Kong's forthcoming full implementation of its Municipal Solid Waste ("MSW") Charging Scheme, Hong Kong Air Cargo Terminals Limited ("Hactl") formed a cross-departmental taskforce in 2022 to develop its strategy. To encourage tenants of Hactl's SuperTerminal1 to fully participate in its revamped waste management approach, and smoothly transition to a low-waste workplace, the company has granted a grace period, during which daily waste disposal records are being maintained with tenants, and corresponding "mock" monthly invoices issued. In addition, Hactl has invested in upgrading its recycling facilities, including installation of reverse vending machines, and refuse bins which automatically sort and handle waste. With these measures, Hactl aims to further increase its recycling and waste diversion rates, and encourage terminal users to consume more consciously.

Hongkong International Theme Parks Limited is pleased to announce that Hong Kong Disneyland Resort ("HKDL") has recently held a launch ceremony for the first car park solar canopy project in Hong Kong, expanding the city's largest single solar installation. Mr Tse Chin-wan, Secretary for Environment and Ecology Bureau, was invited to officiate the ceremony. The project will feature a 200kW solar canopy on top of HKDL's Team Disney car park for cast members' use. With more than 400 solar panels installed, it will generate over 200,000 kWh of electricity annually, and will provide shelter for 80 parking spaces. The event also included the participation of around 50 secondary school students and senior citizens as part of the resort's environmental education initiatives.



**Maxim's Group** marks a significant milestone in the group's sustainability journey with the launch of BOB ("Bottle of Bread"), a locally brewed craft beer made by surplus bread, bread crusts and coffee grounds collected from Maxim's facilities, thereby promoting circular economy. To date, BOB has upcycled over 1.6 tonnes of surplus bread to replace 100% of the barley used. BOB is available in two flavours – "Original BOB" and "Coffee BOB" at approximately 100 Maxim's Group restaurants. For every six bottles of BOB sold, Maxim's Group would also sponsor B-Corp certified social enterprise EcoMatcher to plant one tree in Asia.

The Hong Kong Stock Exchange ("HKEX") recently published a consultation paper proposing to mandate all listed companies to provide climate-related disclosures in their ESG reports for financial years commencing from 1 January 2024. Mr Chester Wong, a partner of **Mayer Brown**, summarises in an article the HKEX's proposed disclosure requirements, which, if implemented, will bring Hong Kong aligned with global baseline for climate-related reporting standards to be published by the International Sustainability Standards Board.

Nano and Advanced Materials Institute ("NAMI") has developed a sustainable aerogel fibre fabricated from spent agricultural waste with low carbon footprint. Ultralight and ultrawarm, this fibre is as fine and strong as wool fibres but 36% lighter. Compared with knitwear made of 100% wool with the same fibre diameter, knitwear incorporating 30% of NAMI's aerogel fibres is 10% lighter, 25% warmer and able to reduce 40% carbon footprint. The aerogel fibre can also be blended with other natural fibres to form yarn and used in commercial automated knitting machines to produce knitwear with a variety of designs.
