## CEO MESSAGE

Dear BEC members,

As we near the end of 2020, we reflect on a challenging year punctuated by the impacts of a global health crisis. We withstood the unprecedented pressures brought on by COVID-19, determined to deliver on our commitment to promote environmental sustainability in the business sector. To ensure our members continue to access the latest sustainability knowledge and support in a socially distanced world, BEC took swift action with a pivot to impactful online or hybrid programmes and events.

Climate change remained an important focus area throughout the year. We marked the first anniversary of The BEC Low Carbon Charter in May when we celebrated our signatories' contributions towards Hong Kong's long-term decarbonisation, and introduced new Charter members. We also published the [Progress Report](#) to influence the wider business community.

As restrictions on gatherings temporarily lifted, we held our flagship EnviroSeries conference in July with the appropriate safeguards in place to bring together over 200 business leaders and sustainability innovators. With contributors from Hong Kong and abroad, we discussed how the business community can work with stakeholders to build back better for a low carbon recovery. We shared those insights in the [Conference Report](#).

One of BEC's main objectives is to be a platform for the business community to voice their views and concerns to the HKSAR Government. We held our annual Summer Meet-up in June where participants discussed government policy related to BEC's three environmental focus areas with the Environment Bureau's representative. We also continued to submit our views, with members' contributions, on topical issues and we are pleased to see our recommendations reflected in strategic documents and policies such as the following:

### ***Council for Sustainable Development's Report on the Public Engagement on Long-term Decarbonisation Strategy***

- Develop a roadmap to progressively advance to net zero carbon emissions by 2050
- Adopt the "avoid-shift-improve" approach, including:
  - reduce the frequency of unnecessary and short-distance journeys
  - switch private car trips to public transport
  - increase the availability and accelerate the shift to low-carbon and cleaner vehicles

### ***BEC's Submission on Long-term Decarbonisation Strategy***

### ***HKSAR Chief Executive Policy Address***

- Achieve carbon neutrality before 2050 and update "Hong Kong's Climate Action Plan" by mid-2021
- Formulate a long-term strategy blueprint on waste management to support circular economy
- Formulate Hong Kong's first roadmap on the popularisation of electric vehicles in the first quarter of 2021

## ReThink 2020

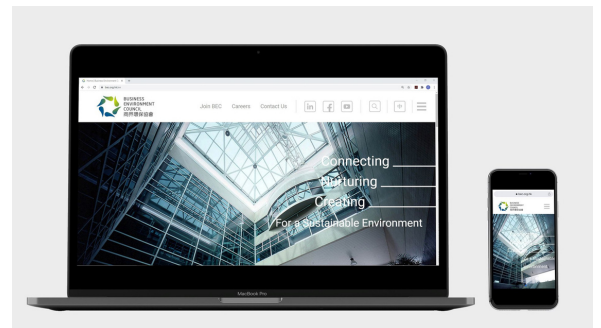

## Is Hong Kong Ready to Ride on China's Carbon Neutral Pledge?

BEC hosted a webinar on 9 November moderated by Director – Policy & Research Mr Simon Ng, with the support of our panel of experts and business leaders to discuss China's landmark and ambitious climate pledge to become carbon neutral by 2060. Key takeaways:

- China's possible decarbonisation pathways in key sectors to achieve carbon neutrality in forty years include phasing out coal use for electricity generation by 2050, electrifying the transport sector, and enhancing energy efficiency in all sectors.
- There are a number of opportunities in Hong Kong to ramp up ambition and action such as popularising the use of electric vehicles and rewarding energy savings.
- It is clear that Hong Kong will have to make a decision soon on its carbon reduction target and its galvanising focus on accelerated and transformational change.

## Accredited Fish Farm Scheme (AFFS)



BEC is working together with the Agriculture, Fisheries & Conservation Department to promote the Accredited Fish Farm Scheme (AFFS), which aims to assist local fish farmers to raise standards and provide sustainable, low-carbon and locally produced aquaculture products to consumers and the catering industry. As part of our promotion strategies, BEC participated as an exhibitor at "Restaurant & Bar Hong Kong x Gourmet Asia 2020" from 11-13 November to promote AFFS to the catering industry, attracting over 1,200 visitors and buyers across three days.

On day 2 of the exhibition, BEC invited representatives from two accredited fish farms to introduce the scheme and their products directly to the attending buyers. To facilitate business matching, Michelin 3-starred chef Mr Albert Au and Le Cordon Bleu chef Ms Bonnie So were invited to provide a cooking demonstration with the accredited fish products!

## TEDxCivic Exchange

Three of BEC's young leaders delivered an insightful presentation on how Hong Kong businesses can expedite a post COVID-19 green recovery at the TEDxCivic Exchange live-stream on 18 November. They explored how corporates can take the lead in Hong Kong's transition to a low-carbon economy and introduced BEC's internal and external initiatives to mitigate climate change.

Key takeaways:

- The pandemic is an opportunity for the HKSAR Government to step up its climate actions. By providing green stimuli, the Government can rebuild the economy, while supporting businesses to invest in climate resilience for the local economy and the built environment.
- The Government should create and encourage more green employment opportunities for the youth in preparation for the low-carbon transition in the coming decades.
- It is imperative for businesses to demonstrate their leadership and implement swift responses to mitigate climate change.
- Good corporate governance and robust data reporting and benchmarking are often overlooked but important to businesses in reducing carbon emissions.

**Sino Land Company Limited** has unveiled its Sustainability Vision 2030 (SV2030), a blueprint guiding its course for 2030 and beyond. In line with its ethos of "Creating better lifescapes", the SV2030 covers crucial areas such as renewable energy, plastic reduction, green buildings and innovative solutions to contribute to a more sustainable future. It also entails goals including reducing greenhouse gas emission by 30% by 2030 from 2012 level; generating renewable energy through, for example, solar panels; halving consumption of single-use plastics across the board by 2022 from 2017 level; as well as developing properties that are wellness-centric.

**HK Electric** has launched a new one-stop free "Smart Power EV Charging Solution" service to assist customers in applying for the Government's \$2 billion EV-charging at Home Subsidy Scheme to install EV charging-enabling infrastructure in the car parks of existing private residential buildings.



Under the new service, HK Electric will provide technical advice on capacity adequacy to cater for additional load of EV charging facilities at concerned buildings. The service team will also carry out a site inspection at the car park on power supply and metering arrangements, as well as advise on the preliminary reinforcement work and facilities. Information on common EV charging solutions and assistance in applying for the Government's subsidy scheme will be provided as well. To promote low-carbon driving, free charging at HK Electric's charging stations has been further extended until the end of December 2021.

**Cundall** was certified carbon neutral in September – the first consultancy in the world to achieve this certification. All direct emissions resulting from the business, indirect emissions from the purchase of electricity, and all business travel are included in the calculation of the practice's carbon footprint across all its offices in the United Kingdom, Europe, MENA, Asia and Australia. Achieving carbon neutrality across the entire business is the first step in Cundall's ambition of becoming a carbon positive business by 2025. This target was originally established in 2012, when Cundall became the world's first consultancy to be formally endorsed as a One Planet Company by a sustainability charity. Since then, the business has become a founding signatory of the Net Zero Carbon Buildings Commitment, and further confirmed its commitment to climate positive action by working with its clients to deliver net zero carbon buildings.

Cundall's commitment to climate positive action is underpinned by science-based targets and is set out in the business's sustainability roadmap, which was published in 2018.

The award-winning upcycled art installation "Wheels of Life" was inspired by the urban oasis concept of a local new hotel and cycling activities - Sha Tin's iconic outdoor element. A total of 88 used bicycle wheels were collected from the community and composed to a leaf-like floating shape. LED tubes installed on the wheels turn the whole installation to an eye-catching sculpture at night. 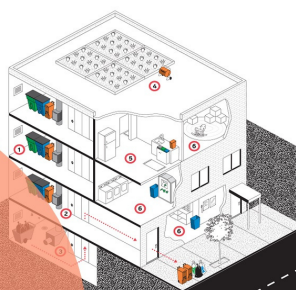
### [Webinar] Designing Buildings for A Zero Waste Hong Kong
