## A TALE OF TWO COPs

***BEC's Director - Policy & Research Mr Simon Ng contributes an article to reflect on two important Conferences of the Parties ("COPs") and connect the dots between climate emergency and biodiversity loss.***

After a one-year delay due to COVID-19, the 26th United Nations Climate Change Conference of the Parties ("COP26") will officially open on 31 October in Glasgow, United Kingdom ("UK"). This is a highly anticipated event, arguably the most important COP since Paris in 2015, with a determined tone set out loud and clear in recent months by heads of state, politicians, business leaders, climate scientists, environmental activists and the youth that this is perhaps "the world's last best chance to get runaway climate change under control". Only ambition and collaboration will help us reach at least net zero carbon emissions by mid-century or sooner (aka the "Race to Zero").

As the host, the UK Government set out 4 ambitious goals for COP26: (i) secure global net zero by mid-century and keep 1.5 degrees within reach; (ii) adapt to protect communities

and natural habitats and build resilience; (iii) mobilise finance in the order of at least US\$100 billion per year to realise the first two goals; and (iv) work together between governments, businesses and civil society to deliver the climate goals quicker. There was also a call on all nations, especially major greenhouse gas emitters like China, the United States, Europe and Japan, to submit ambitious targets and strengthen their commitments with solid and enhanced Nationally Determined Contributions ("NDC") this year, as it becomes clear with the latest predictions from the first part of the Sixth Assessment Report ("AR6") of the Intergovernmental Panel on Climate Change ("IPCC") published in August 2021 that the current NDCs are collectively falling short of meeting the goals of the Paris Agreement.

Despite the frustration with COP25 and the sizable challenge we are all facing with the climate emergency, there is renewed optimism around the world given how we responded to the global pandemic and how determined we are to "build back better". It is extremely promising to see global brands and business leaders stepping forward one after another in committing to ambitious carbon reduction targets and climate initiatives. Since 2019, for the record, the number of companies committed to Science Based Target initiative ("SBTi") has risen from a few hundreds to over 2,000. More than 950 companies representing market capitalisation of over US\$13 trillion have signed the Business Ambition for 1.5°C and committed to set ambitious science-based targets.

Prior to G20 Summit and COP26, over 600 businesses from across the globe called on G20 leaders to go all in to limit global temperature rise to 1.5 degrees.

Since Hong Kong's pledge to become carbon neutral by 2050, BEC maintains that the next decade up to 2030 will be critical and decisive. It is therefore encouraging that the SAR Government announced Hong Kong's Climate Action Plan 2050 ahead of COP26, with the aim to reduce the total carbon emissions by 50% before 2035 from the 2005 level through the four-pronged decarbonisation strategies of net-zero electricity generation, energy saving and green buildings, green transport, and waste reduction. The Government also

answered to BEC's request by setting up a new, dedicated Office of Climate Change and Carbon Neutrality to strengthen public-private, multi-sector co-ordination of climate action. With the target set last year and now an updated plan with comprehensive strategies put together, it is down to the Government, the business sector and the wider community to join up and achieve net zero.

In mid-October, another COP summit was concluded in a relatively low-key fashion. The first part of the Fifteenth Meeting of the Conference of the Parties to the Convention on Biological Diversity ("CBD COP15") took place in Kunming, China from 11-15 October. This is the biggest biodiversity conference in a decade for world leaders to discuss and agree on the post-2020 Global Biodiversity Framework, with a shared vision of living in harmony with nature by 2050. 195 countries and the European Union pledged to protect and conserve 30% of land and sea areas by 2030 to ensuring that biodiversity is on a recovery pathway within the next decade. In addition, China pledged to set up a 1.5 billion yuan Kunming Biodiversity Fund, whereas Japan will make a US\$17 million extension to the Japan Biodiversity Fund, with the aim to protect and restore biodiversity in developing countries. All in all, progress has been made.

While COP26 is attracting all the attention due to the climate emergency, let's not forget biodiversity loss is an equally significant threat to mankind. In fact, the nature and climate crises are inter-connected. Nature's regenerative power is also vital to climate mitigation, adaptation and resilience. For the business sector, "doing no harm" to Planet Earth is no longer good enough as businesses should instead look to support the ecosystem for self-healing and recovery through a regenerative approach. Businesses often overlook the materiality of biodiversity to companies, as the operational impacts of business on nature and biodiversity loss are typically considered over their dependencies on the ecosystem. It is necessary for business organisations like BEC to facilitate a conversation with corporate leaders on why nature loss is a major material risk to business, and how nature-positive business strategies and nature-based solutions could be mainstreamed in the corporate world.

## Drivers for Sound Corporate Climate Governance: Insights on Board Governance & Stakeholder Communications



Following our recent release of "Corporate Governance for Climate Resilience: Emerging Challenges and Opportunities for Companies in Hong Kong" report, BEC was pleased to invite Mr Jamie Allen, Dr Margaret Burnett and Mr John Haffner to our webinar on 27 September to share their insights on board governance and stakeholder communication to enable strong climate governance and awareness. A special thanks to Dr Jeanne Ng for being our moderator of the panel discussion.



### Key takeaways:

- There is a need for companies and regulators in Hong Kong to connect climate governance strongly with ESG through the CG Code and investor stewardship codes which is otherwise considered in silo with the misconception that one is the substitute of another.
- The changing landscape of ESG has redefined companies' approaches to sustainability - from a reactive, indicator-focused disclosure inclined towards mitigation to a more proactive engagement with company Boards which focuses on strategic planning, resilience and adaptation.
- Materiality assessment has the potential to mainstream ESG practices and perceive risks as the missed opportunities. For instance, companies can look upstream, engage value chain partners and investors directly to address the right issue with the right data.

## Transitioning to Future Net-Zero Buildings

### Key takeaways:

- Data is key to the net zero transition of the built environment – they tell us where we are and where we need to go.
- A massive mindset shift will be needed for the buildings and construction value chain professionals – from seeking to design new projects and buildings, to seeing the value in improving existing ones.



## ReThink HK 2021

ReThink HK 2021 was concluded with great success. As the exclusive co-organiser, BEC put together a series of insightful programmes at the BEC Theatre with the theme “Empowering Businesses to Lead for Impact” on Day 1 (5 October). We were pleased to have our Chairman Mr Richard Lancaster and other business leaders and experts sharing their views on various sustainability issues.

### Key takeaways for Day 1:

- Companies should think long term. Business leaders should treat shareholder value and stakeholder value with equal importance – while it seems they are in conflict now, there will be no difference very soon.
- Metrics are important to drive and track change. They need to be open, transparent and accountable.
- Purpose is the new profit for business, and business with purpose is in the best position to recruit and retain talents.



On Day 2 (6 October), BEC delivered a programme tailor-made for SMEs at the BEC Theatre. Through sharing and discussions, we identified some pain points on SMEs’ sustainability journeys and offered constructive feedback and solutions.

### Key takeaways for Day 2:

- The idea of trading off the environmental, economic and social aspects of sustainability against one another is no longer acceptable today.
- ESG will benefit corporate development and raise competitiveness. Green transformation is key to SMEs in post-COVID recovery.
- Resource management, governance, innovation, customer and supplier relationship are some key focus areas for SMEs to bring sustainability into practice.
- Partnership is essential for SMEs to foster sustainability as they often lack resources.
- Consumers care more about sustainability post-COVID. Environment, health and well-being are their paramount concerns. SMEs should take actions or they risk losing the market.



## Chief Executive's 2021 Policy Address

BEC welcomes the Government's commitment in the 2021 Policy Address to strive for reducing the total carbon emissions to half of 2005's level by 2035, with the goal of achieving carbon neutrality before 2050. Key proposals include:

- Establish the Office of Climate Change and Carbon Neutrality
- Cease the use of coal and replace with natural gas and renewable energy for local power generation by 2035
- Reduce the electricity consumption of commercial and residential buildings by 30-40% and 20-30%, respectively, from the 2015 level by 2050

Since our establishment, BEC has been Hong Kong's leading coalition promoting environmental excellence to our members and the wider business sector. With our environmental focus areas of climate change, sustainable living environment and circular economy, BEC focuses on empowering Hong Kong's business community to take leadership in post-COVID green recovery, and to contribute to Hong Kong's long-term sustainability.

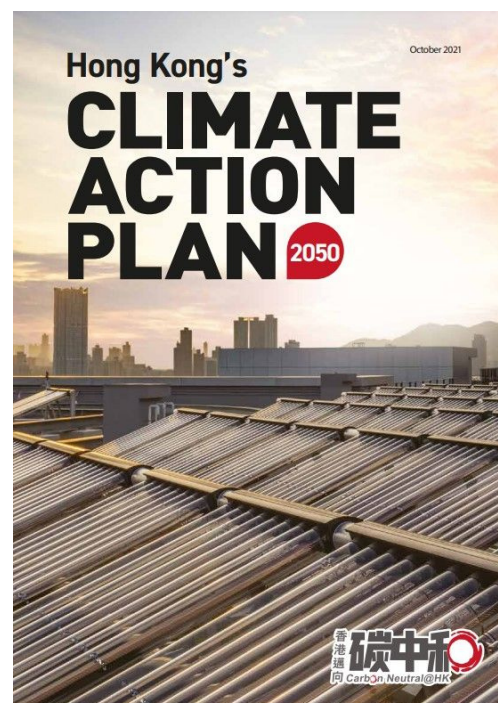
### Chief Executive's 2021 Policy Address

## Hong Kong's Climate Action Plan 2050

BEC welcomes the publication of Hong Kong's Climate Action Plan 2050 on 8 October. With the four-pronged decarbonisation strategies of net-zero electricity generation, energy saving and green buildings, green transport, and waste reduction, the Government aims to reduce the total carbon emissions by 50% before 2035 from the 2005 level.

The updated plan demonstrated Hong Kong's ambition to not only combat climate change through decarbonisation strategies, but also enhance the adaptation and resilience capability of the city. It is a timely response ahead of the upcoming COP26 in Glasgow.

Achieving carbon neutrality by 2050 is a challenging task in the highest order, which requires cross-sector, all-hands-on-deck effort to stand any chance of success. With the target announced last November and now an updated plan with comprehensive strategies put together, it is down to the Government, the business sector and the wider community to work together and "race to zero".

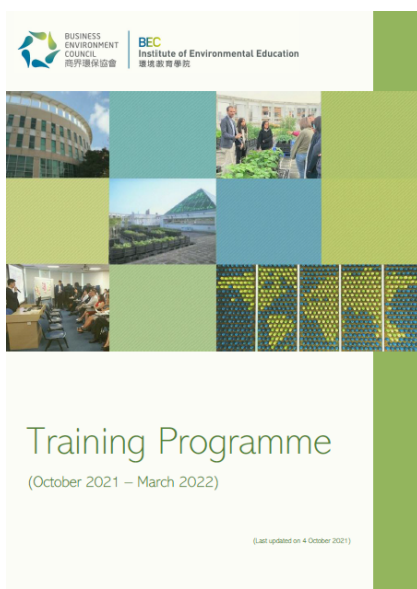

During the event, AAHK provided updates on its long-term carbon target, the Climate Resilience Study, and the airport-wide Green Airport Design and Construction Strategy. To keep up with latest industry trends, AAHK also invited external speakers to give a briefing on the Public Engagement on Control of Single-use Plastics and introduce the Food TranSmarter, which is the first-ever system in Hong Kong to automatically liquefy food waste into slurry.

In September, **Swire Properties** had its new 1.5°C-aligned science-based targets (“SBTs”) approved, which are approximately 50% more aggressive than its original 2°C-aligned SBTs approved by the Science Based Targets initiative in 2019. In addition to reducing absolute scope 1 and 2 greenhouse gas (“GHG”) emissions by 46% by 2030 (from 2019 the baseline year), the company has also committed to reduce scope 3 value chain emissions (covering both upstream and downstream). These targets set the company on the right path to reaching net zero emissions by 2050 and support the Hong Kong Government’s 2050 carbon neutrality pledge.

Vegware is dedicated to promoting plant-based disposables recycling and supporting a circular economy in the food sector.

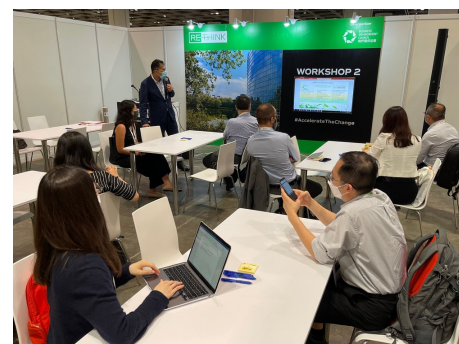

Approximately half of the worldwide population (53%) find buying healthy and sustainable food easy according to a new global consumer research survey conducted by **GlobeScan** and a science-based non-profit making organisation for global food system transformation. In August, **TÜV Rheinland** issued the world’s first Ocean Bound Plastic (“OBP”) Recycled Content certificate to a Chinese enterprise. Based on a scientific verification of the OBP sources and its content ratio in specific products, the company’s technical experts reviewed the entire process of collection, sorting, washing, pretreatment, high-quality modification and recycling, and transportation by manufacturers, recyclers and collectors, before awarding the certificate. The use of OBP in turning low-value plastic waste into high-quality plastic will make the best use of plastic, thus having a far-reaching significance in achieving peak carbon dioxide emissions and carbon neutrality goals.
