## Remarks:

- Charitable institutions registered under section 88 of the HKSAR Inland Revenue Ordinance and statutory bodies governed by the related HKSAR statutory ordinance are eligible to join as Affiliate Members. Supporting documents are required.
- There are 16 Steering Committee Member seats for each Advisory Group. Not more than 2 seats will be allocated to General Members.
- Each General Member is eligible to join maximum 2 out of 3 Advisory Groups as Advisory Group Members, regardless they are a Steering Committee Member or Ordinary Member.
- The quota is counted per calendar year. For new members joining in the middle of the year, a pro-rata basis will be adopted.
- If the Anniversary Dinner could not be organised during that year, a complimentary seat for another paid event will be offered to new members as an alternative.
- Subsidiaries of existing Council Members can enjoy joining fee exemption when joining the Council Membership tier. Supporting documents are required.
- A 10% discount will be offered for 3-year membership subscription.
