



BEAM Plus Familiarisation Training for Site Supervisors (82908)

BEAM Plus requires **Site Supervisors** to supervise a series of good site practices in order to fulfill pre-requisite requirements or attain credits especially for the site management and supervision as well as testing and commissioning. Those requirements may create difficulties to **Site Supervisors** for demonstrating compliance. This 3-hour course offers a comprehensive training that covers everything the **Site Supervisory Staff** need to know to manage their **BEAM Plus** responsibilities.
