Case Sharing on First Commercial Building to achieve BEAM Plus Provisional Platinum Rating (Existing Buildings) – BEC Headquarters (83101)

Hong Kong currently has over 40,000 existing buildings that account for 92% of total electricity demand in the territory. The Hong Kong Green Building Council ("HKGBC") launched the "HK3030" Campaign in December 2012 and put forth a roadmap to reduce the absolute electricity consumption of buildings in Hong Kong by 30% of the 2005 level by 2030. In order to build a low carbon sustainable built environment, the BEC headquarters was upgraded to a green building by implementing a number of green features and practices. These energy and water saving features include installation of oil-free variable speed air-cooled chiller and rainwater collection system. BEC Headquarters is the first commercial building in Hong Kong which has achieved the Platinum rating of Provisional Assessment under BEAM Plus Existing Buildings (version 1.2) of HKGBC on 13 August 2014. This 3-hour-long course introduces some essential knowledge of design, planning and implementation for transforming an existing building to a certified green building.
