Last year was an eventful year for sustainable development in Hong Kong, showing the importance of the business community working together to help develop plans and policies towards the shared goal of a sustainable future. The Climate Action Plan 2030+, Hong Kong 2030+, as well as the Hong Kong Smart City Blueprint were issued, setting out measures for achieving carbon emissions reductions and building Hong Kong into a world-class smart city.

In the year ahead, opportunities and challenges will continue to arise for businesses and the community in Hong Kong. Details of the municipal solid waste charging and the feed-in tariff scheme for renewable energy installations will be announced this year. BEC will take forward its various projects including working with members to set carbon reduction targets, enhance energy efficiency, and help Hong Kong transition towards sustainable consumption and a circular economy.

Let's work together in extending our joint efforts to make Hong Kong more liveable with the ability to sustain its prosperity and quality of life for generations to come.

## GREEN INITIATIVES IN LUNAR NEW YEAR FAIR AT VICTORIA PARK



In collaboration with the Environmental Protection Department (EPD) and the Food and Environmental Hygiene Department (FEHD), BEC has successfully invited over 200 stall owners in the Lunar New Year Fair at Victoria Park to join "BEC Green Event Charter", a green initiative encouraging event organisers to manage their wastes more responsibly.

BEC also recommended a series of green initiatives to the two Departments which included 23 sets of recycling facilities and 3 resources recycling corners established in the Fair for stall owners to recycle and donate their unsold goods and stall materials. Most of the bulky materials, such as marquees, refrigerators, ladders, chairs and desks, were donated to charitable organisations, while bamboos, wooden pallets and unsold peach blossom trees were sent to NGOs and elderly homes for recycling and upcycling.

### Road Transport Dialogue Platform – Second Meeting on “The Transition to Hybrid and Electric Buses & Commercial Vehicles”



With support from the Environment Bureau and the Transport and Housing Bureau, this Platform aims to develop impactful action towards a clean low carbon transport and logistics system. It will involve an on-going dialogue between businesses in this sector to identify issues for detailed discussion with the Government.
