# PACKAGING REDUCTION CHARTER LAUNCHING CEREMONY

The Packaging Reduction Charter (the "Charter"), launched by the Environmental Protection Department ("EPD") and supported by BEC, successfully concluded its launching ceremony on 31 March 2025. This meaningful initiative has garnered support from over 100 local and multinational companies, with more than 80 signatories and supporting organisations joining us at the landmark ceremony, united in the mission to reduce packaging waste and contribute to Hong Kong's Zero Landfill and carbon neutrality goals.

The ceremony, officiated by Mr Tse Chin-wan, Secretary for Environment and Ecology, emphasised the pressing need for action as a significant portion of packaging waste still ends up in landfills each day. The Charter aims to encourage businesses to adopt sustainable packaging practices by reviewing packaging designs to minimise unnecessary material usage, enhancing recyclability and reusability, and exploring innovative packaging management solutions. These efforts are vital in supporting Hong Kong's long-term goals of achieving "Zero landfill" and carbon neutrality. During the event, Ms Kelly Lee, Senior Vice President at HKEX, also shared valuable insights on climate disclosures and supply chain emissions, highlighting how the Charter aligns with broader ESG priorities.

### BEC Net-zero Carbon Charter: Strengthening Corporate Leadership in Climate Disclosure

BEC held the "BEC Net-zero Carbon Charter: Strengthening Corporate Leadership in Climate Disclosure" event on 1 April, bringing together around 100 representatives from various sectors to mark the conclusion of the 2024 disclosure cycle under the <u>BEC Carbon Disclosure Programme</u>, which was launched in 2022 to assist signatories of the BEC Net-zero Carbon Charter and the broader corporate sector in enhancing climate-related disclosures.

During the event, participants engaged in insightful discussions on key topics, including:

- Key global disclosure trends and insights from the 2024 Disclosure Cycle
- Local practices and achievements in climate disclosure among Hong Kong businesses
- Effective strategies for managing emissions across the value chain
- Discussion on leveraging climate disclosure for strategic advantage





### BEC CEO Dialogue - Sustainable Architectural Design and Sustainable Property Development for a Net-zero Future

The latest BEC CEO Dialogue themed "Sustainable Architectural Design and Sustainable Property Development for a Net-zero Future" was successfully held on 2 April. We were honoured to have Ar Ivy Lee, Managing Director and Head of Sustainability at Leigh & Orange Limited, as the guest speaker to exchange insights with BEC CEO Mr Simon Ng on innovative strategies and best practices for integrating sustainability into architectural design and property development.

Ar Lee emphasised the importance of collaboration among stakeholders in the architectural and property development sectors. She noted that sustainable practices not only contribute to environmental goals but also enhance the resilience and liveability of communities. The discussion also highlighted the critical role that sustainable design plays in achieving a net-zero future for Hong Kong.

### Putting Nature on the Balance Sheet: Launch of the TNFD's LEAP approach in Hong Kong

BEC and Hong Kong Green Finance Association ("HKGFA") co-hosted the "Putting Nature on the Balance Sheet: Launch of the TNFD's LEAP approach in Hong Kong" webinar on 3 April. It marked the first capacity-building activity organised by the newly established Taskforce on Nature-related Financial Disclosures ("TNFD") Consultation Group in Hong Kong, coconvened by BEC and HKGFA.

The webinar attracted over 420 participants and marked the official launch of the TNFD <u>LEAP approach</u> in Chinese, which signifies growing momentum and makes it more accessible for businesses in Hong Kong and across the region to embark on their journey in assessing and reporting their nature-related issues.

During the webinar, TNFD experts and TNFD adopter company representatives gave insightful sharings and engaging discussions on topics including:

- The growing global adoption of the TNFD framework and the LEAP approach (Locate, Evaluate, Assess, Prepare)
- The business case for engaging with nature-related disclosures
- Local experiences and challenges in implementing the framework using the LEAP approach among Hong Kong businesses
- Opportunities for businesses that start early and getting ahead amid a growing movement for business action on nature

### BEC Technical Visit - Urban Oasis: Biodiversity Tour at Taikoo Square



On 11 April, BEC successfully hosted the BEC Technical Visit - Urban Oasis: Biodiversity Tour at Taikoo Square. Ms Joey Lau, Manager, Sustainable Development from Swire Properties introduced the master plan for Taikoo Place and explained how biodiversity considerations and biophilic design are integrated into the redevelopment of Taikoo Place to create a vibrant, sustainable neighbourhood. Next, participants joined a guided tour of the Taikoo Square led by Outdoor Wildlife Learning Hong Kong, where they explored native species introduced to the garden and gained a deeper understanding of their role in promoting urban biodiversity.

### **Getting Ready for the Carbon Market**



Co-organised by BEC and Sustainability Professionals Association with the sponsorship support from Invest Hong Kong, the "Getting Ready for the Carbon Market" seminar held on 16 April was a tremendous success. The seminar discussed the vital topics of carbon trading and market development, especially in the context of recent advocacy for Hong Kong's evolution into a carbon trading centre.

### **Council Members**

**Airport Authority Hong Kong ("AAHK")** unveiled its "Treasures of the Western Waters" exhibition on 2 April at Hong Kong International Airport ("HKIA"). From now until 8 June 2025, passengers and the general public can explore the diverse underwater marine environment and learn about AAHK's impressive efforts to enhance marine ecology and biodiversity in waters near HKIA at the exhibition. The exhibition marks the beginning of a series of activities showcasing AAHK's efforts in marine and fisheries enhancement and conservation with a series of public engagement activities to follow. Upcoming activities include educational eco-tours for students and other stakeholders, ongoing deployment of Artificial Reef units in waters near HKIA and a fish restocking exercise on the same day as the National Fish Releasing Day on 6 June 2025.

**Henderson Land** unveiled Art Garden at The Henderson, Asia's first sculpture garden designed by a world renowned architectural firm. The space transcends the traditional garden, reimagining a refurbished public area into an urban art sanctuary through a pioneering public-private partnership, where art, innovation, and sustainability converge to offer a serene retreat in the city's heart in Central. The Art Garden is a living gallery where nature and creativity intertwine. Ned Kahn's Breathing Tree; Fractal Forest by local art duo STICKYLINE x Leanna Lee; and Hypnotic Dream by Philipp Frank transforms a 200-year-old Chorisia tree into an enchanting vision, immersing visitors in a new dimension of urban artistry with bespoke soundscapes.

**Towngas** has achieved significant progress in promoting green methanol for sustainable shipping. It recently executed Asia's largest green methanol bunkering operation in Shanghai, supplying 2,902.5 tonnes to the Korean vessel "HMM Green". Additionally, Towngas announced a Singapore-based bunker supplier will procure its green methanol, marking a significant expansion in Asia. Produced from biomass and municipal waste, Towngas' ISCC-certified green methanol achieves a greenhouse gas reduction of up to 70% over its lifecycle. The production facility in Inner Mongolia will increase its annual capacity from 100,000 tonnes to 150,000 tonnes by 2025. Towngas is also collaborating with a Chinese energy company to establish multiple production bases across China, targeting a combined one million tonnes annually. These efforts underline Towngas' leadership in driving sustainable shipping and supporting the global low-carbon transition.

### **Corporate Members**

**Chow Tai Fook Jewellery Group** has been included in the Dow Jones Best-in-Class World Index for the first time and in the Dow Jones Best-in-Class Asia Pacific Index for the second consecutive year. The Dow Jones Best-in-Class World Index represents the top 10% of the largest 2,500 companies in the S&P Global Broad Market Index, while the Asia Pacific Index includes the top 20% of 600 largest companies in the Asia-Pacific developed region. As the only Asian jewellery company included in both indices, these recognitions reflect Chow Tai Fook Jewellery's deep-rooted commitment to sustainability and its continued efforts to drive positive change in the jewellery sector.

Green transport is vital to Hong Kong in achieving carbon neutrality before 2050. To meet the increasing charging demands of different types of electric vehicles ("EV"), **CLPe** has launched an EV charging service focusing on fast and super-fast charging, and offers a variety of charging solutions for commercial vehicles, including taxi fleets, light goods vehicles, and limousines. CLPe is also partnering with fellow BEC Member Link Asset Management Limited and other property developers and management companies to expand the charging network with convenient spots located in the city centre. More than 250 charging bays will be in service across Hong Kong this year.

Echoing the theme "Our Power, Our Planet" of Earth Day 2025, **HAECO** dedicated April to celebrating the planet through "HAECO Earth Month". The company organised a series of events to engage its staff in environmental conservation, including a mangrove adventure in Mai Po and coral reef appreciation at Hoi Ha Wan. Furthermore, the "South Perimeter Road Clean Up" saw its staff coming together to collect 30 kg of trash, including 13 kg of recyclables. This effort helped clean up the surrounding neighbourhood while protecting the natural beauty and biodiversity along the coast of Hong Kong International Airport. Understanding every small effort leads to significant changes, HAECO will continue to encourage its staff to adopt a sustainable mindset both at work and at home.

**Hong Kong Disneyland Resort** celebrates Earth Month by utilising clean energy for amusement taxi rides. The resort's facility services team has converted the Main Street Taxi – a beloved feature of Main Street, U.S.A. – to electric power by replacing its existing gasoline engine and hydraulic transmission system with a motor. This innovative step prevents waste by modifying the resort's existing vehicles. The electricity-powered Main Street Taxi retains its vintage appearance – a nod to the elongated horseless carriages of the early 1900s. An onboard audio system has been added to simulate the sound of a gas engine. This elevates the nostalgic ride experience for guests, with improved air quality.



Recognised as one of the most respected publications evaluating corporate sustainability efforts, the S&P Global Sustainability Yearbook highlights companies with outstanding ESG performance. This inclusion reflects SGS's continued commitment to integrating sustainability into its operations and delivering responsible business practices. In 2025, S&P Global assessed 7,690 companies across 62 industries as part of its 2024 Corporate Sustainability Assessment. This year, only 780 companies met these rigorous standards for inclusion. This recognition reinforces SGS's leadership in sustainability and its ongoing dedication to driving positive impact through its services, innovation and ESG initiatives.







### **General Members**

AEL (International Holdings) Limited is invited as an exhibitor at the "Innovative Pathway: Hong Kong's New Era of Industry" exhibition held in Hong Kong Science Museum. Running from 11 April to 2 July, this event will feature over 50 exhibits highlighting the innovative contributions of local researchers and industrialists across various fields. The exhibition aims to showcase how cutting-edge technologies are addressing real-world challenges, enhancing production efficiency, and improving product quality, ultimately fostering a new era of industrial productivity. As a company deeply committed to environmental protection and sustainability, AEL will be showcasing its state-of-the-art food waste recycling system, which represents its dedication to solving one of the most pressing global issues—food waste management.

On 21 March, **ALBA Group Asia** Hong Kong office hosted Eco Impact: E-waste and Carbon Reduction at WEEE-PARK, highlighting its recycling achievements and sustainability partnerships. The event celebrated the recycling of over five million pieces of regulated e-waste since the start of operation. Carbon reduction certificates and appreciation awards were also presented to the company's business partners, NGOs, and property management companies in recognition of their contributions to the net CO<sub>2</sub>e reduction of 88,835 tonnes in 2024 at WEEE-PARK. Dr Samuel Chui, Director of Environmental Protection, attended as the Guest of Honour, who delivered a very inspiring speech and celebrated the success with ALBA's stakeholders.





**Cathay Cargo Terminal** and a fellow Cathay subsidiary have recently begun piloting the use of Hydrotreated Vegetable Oil ("HVO") as an alternative fuel for Ground Service Equipment, underscoring both companies' commitment to decarbonisation. HVO is a renewable diesel alternative that offers a cleaner combustion process, reducing over 80% of lifecycle carbon emissions compared to traditional diesel fuel. The Cathay subsidiary is the first ramp handling operator at Hong Kong International Airport to utilise HVO.

China Overseas Land and Investment Limited ("COLI") is included in the S&P Global Sustainability Yearbook 2025 for the first time, highlighting its exceptional sustainability efforts. COLI stands as the sole Chinese real estate firm to secure this recognition, underscoring its prominent position in ESG practices. S&P Global Sustainability Yearbook is one of the world's most authoritative and indicative ESG assessments. The Yearbook draws upon the S&P Global Corporate Sustainability Assessment ("CSA"), which comprehensively evaluates companies across Environmental, Social and Governance dimensions. Companies with a CSA Score of at least 30, ranking within 15% of the industry's top-performing companies by number would be selected.

Heidi Spurrell from **Future Green** is recognised as one of Harper's Bazaar's Visionary Women of the year, highlighting her impactful work in advancing environmental sustainability through food systems. As the founder of Future Green, Heidi's leadership bridges the gap between business and sustainability, empowering companies to adopt climate-conscious decisions, procure sustainably, and promote circular solutions. This recognition not only celebrates her personal achievements but also brings greater visibility to the urgent need for systemic change in how humans produce and consume food.

New global research from **GlobeScan** shows that water pollution is the number one environmental issue for people globally and that there is a growing appetite for efforts to tackle water challenges, including greater emphasis on the protection and restoration of freshwater ecosystems and on collective action by companies. The company's new report "The Future Water Agenda: How water can lead the way for sustainability and collective action" offers insights to enhance corporate water stewardship, foster collective action on water challenges, and improve stakeholder engagement.

**HK Express**' "Gotta GO! Sustainable Explorer Challenge" ("SEC") has returned. SEC is designed to deepen students' understanding of sustainability concepts and empower them to create lower-carbon travel adventures while putting sustainable travel into practice. SEC returns on a larger scale this year, expanding from two to four university partners and welcoming over 470 passionate students, nearly triple last year's participation. In February, the challenge kicked off with lectures introducing students to HK Express' sustainability journey, exploring sustainable tourism principles, and providing practical tips to avoid greenwashing. In March, the company hosted a series of interactive workshops focused on carbon emission calculations, sustainable tourism best practices, itinerary planning, and impactful storytelling for proposal writing and presentation.


