# **POST-COP27 HONG KONG FORUM**

BEC, Civic Exchange, and HKUST Institute for the Environment and Division of Environment and Sustainability coorganised Post-COP27 Hong Kong Forum on 12 January for Hong Kong's COP27 participants to share their observations with the Hong Kong business community and other key stakeholders.

BEC Chairman Mr Kevin O'Brien kick-started the event with his opening remarks, highlighting the important, positive mindset shift of the global business community from making pledges to deploying concrete action to decarbonise their business shown in COP27 held in Egypt in November 2022. He said, "We are glad to see a breakthrough in COP27 from decade-long discussions to support the most vulnerable and least developed countries disproportionately affected by climate change by setting up a 'loss and damage' fund, in which countries responsible for high carbon emissions will compensate vulnerable countries suffering from climate impacts."

Specialist from HKUST, European Union Office, and Civic Exchange were invited to share some key COP takeaways on "Climate Science", "Climate Negotiations" and "Young Talent Perspective" with the audience, followed by two insightful panel discussions on the topics related to the

pressure for decarbonisation shifting to non-state actors and the transition plan on how to deliver the change that is needed.

BEC Climate Change Business Forum Advisory Group Chair Ms Susanna Wong concluded the forum by giving the closing remarks. She suggested that there is little sight

that national governments are taking more ambitious climate commitments. Financing gap remains there to support climate actions. However, it is encouraging to see some business and non-state sectors stepping up with more concrete actions, such as defining net-zero to avoid greenwashing and pushing more transparent disclosure to systematically guide decarbonisation actions. Meanwhile, financial institutions and corporates are also taking more robust actions to plan for low-carbon business transition model and explore how to finance the mitigation actions needed.

In Hong Kong, some large corporates are taking climate change seriously in their business strategy. Since financing is the key to drive necessary actions and deliver the transition at both local and global levels, Hong Kong should step up in this aspect in order to strengthen our leadership position.

#### BEC Building Achieves Final Platinum rating under BEAM Plus Existing Building Version 2.0

BEC Director – Operations Ir C.F. Leung says a number of resource efficient initiatives have been implemented to retrofit the building services equipment and encourage behavioural changes among users of BEC Building

BEC Building, formally known as Jockey Club Environmental Building ("JCEB"), has achieved the top Final Platinum rating under BEAM Plus Existing Buildings Version 2.0 Comprehensive Scheme.

With an overall score of 92, BEC Building retains its Final Platinum rating from the previous 2017 assessment. Among the six assessment aspects, the building performed exceptionally well and achieved over 90% credits in "Site Aspects", "Materials and Waste Aspects", and "Energy Use". Its outstanding energy performance is also found to be among the top 10th percentile of other similar premises.

BEC welcomes group tours in which our "Green Lab" professionals will guide the visitors through our sustainable journey of retrofitting and motivating behavioural changes.

Under the Programme, BEC is organising this event together with CDP and HSBC to recognise the current climate disclosure landscape among Hong Kong businesses, support corporates and SMEs to participate in climate disclosure, and inform the 2023 CDP disclosure cycle and encourage companies to participate.

The multi-dimensional ESG risk assessment measures AAHK's management and exposure on industry-specific material risks. AAHK was rated as "low risk" and ranked in the top 5 in the airport sector out of the 82 evaluated airports and in the top 3rd percentile globally in terms of ESG performance. Strong scores were attained across business ethics, corporate governance, occupational health and safety, community relations and emissions, effluents and waste areas.

Reduced embodied carbon was achieved in part through the use of sustainable materials and the elimination of a suspended ceiling. To reduce operational energy use, the renovated headquarters maximises access to natural light, and the artificial lighting adapts to the time of day and the environment. Elsewhere, energy metering and Internet of Things ("IoT") devices are used to monitor, analyse, and respond to energy efficiency and indoor air quality levels in real-time. Chinachem has decided to pursue WELL certifications for this renovation project, and this thoughtful design has also demonstrated how Chinachem cares about the wellbeing of its employees and the environment.

The 6,500-square-metre facility is dedicated to realise the ambition of "closing the loop", by processing PET plastic bottles in Hong Kong to produce food-grade ready rPET flakes and rHDPE flakes for various recycling usage, with the designed maximum handling capacity throughput up to 900 tonnes.



The retrofit is expected to achieve an annual energy reduction of over 67%, or 33,800 kWh, and carbon emissions by over 27,000 kg with a payback period of just 2.8 years.


