


## BEC GREEN FINTECH FAIR

The inaugural BEC Green Fintech Fair successfully concluded on 8 January at BEC Auditorium, bringing together over 200 participants to explore developments in green fintech. Sponsored by Invest Hong Kong and held in partnership with Hong Kong Green Finance Association and Civic Exchange, the event featured an engaging forum where industry leaders brought insights on regulatory trends, product disclosures, and the carbon market.

We were honoured to have Mr Joseph Chan, JP, Under Secretary for Financial Services and the Treasury, and Mr Kevin O'Brien, Chairman of BEC, officiating at the forum and addressing the audience on the critical role of green fintech in driving the transition to a net-zero economy.

In Mr Chan's opening speech, he restated that Hong Kong is the leading green and sustainable finance hub in Asia, accounting for about 45% of the regional total green and sustainable bonds issued in 2024. To accelerate the green transformation of the economy, the Government has launched various initiatives, including the world's first digital green bonds in 2023 and the "Green and Sustainable Fintech Proof-of-Concept Funding Support Scheme" in 2024, fostering collaboration between tech companies and local businesses to develop innovative green fintech solutions.



Mr Kevin O'Brien said, "BEC Green Fintech Fair creates a platform for matching opportunities for our members and the wider business community with green fintech exhibitors. This fair enables our exhibitors to understand corporate needs, while corporates can learn about innovative solutions that help them achieve their sustainability targets. The synergy is critical for driving sustainable solutions and enhancing the competitive landscape of the green fintech market in Hong Kong."

Reflecting on Hong Kong's position in green fintech, Mr King Leung, Global Head of Financial Services, FinTech & Sustainability at Invest Hong Kong, remarked, "Hong Kong stands as a leading fintech ecosystem in Asia, driving sustainable finance innovation. Bolstered by the Government's strong policy commitment and initiatives like the Green Fintech Map, the city flourishes with real-world data-driven solutions, investable green assets, and advanced climate risk management for portfolios, propelling overarching business transformation toward a net-zero future."

Alongside the forum, 19 companies and start-ups joined the expo in BEC Exhibition Hall to showcase their innovative products and services. The expo fostered opportunities for collaboration and business development among technology providers, financial institutions, and sustainability practitioners. Feedback from speakers, exhibitors and participants was highly positive, recognising the fair as a valuable platform for knowledge exchange and cross-sector engagement in green fintech.

## Post-COP30 Hong Kong Forum: From Belém to Business: Global Narrative, China's NDCs, and Hong Kong's Role in the New Climate Economy



The Post-COP30 Hong Kong Forum on 13 January welcomed an impressive turnout at BEC Auditorium, sparking meaningful dialogue on the outcomes of COP30. We were pleased to have Mr Arthur Lee, Commissioner for Climate Change, Environment and Ecology Bureau, sharing an overview of the HKSAR government's engagement at COP30 and Hong Kong's contribution to China's Nationally Determined Contributions. In November 2025, our CEO Mr Simon Ng attended COP30 in Belém, and gained first-hand insights into global climate imperatives. At the forum, he reflected on his experience and discussed international interest in Hong Kong businesses' climate actions and leadership.

The event also featured thought-provoking presentations by Mr Wai-shin Chan from Metis ESG and Mr Tony Zhao from the University of Hong Kong, followed by a panel discussion on the 2026 outlook for Hong Kong businesses. Moderated by Mr Merlin Lao, BEC Head – Policy & Research, the panel brought together Ir Dr Bruce Chong from Arup, Ms Hao Tian from Global Climate Finance Accelerator, Mr Kendrew Leung from Financial Services Development Council, and Ms Landico Wong from DFI Retail Group. Key topics included regulatory divergence and uncertainties, supply chain resilience, and mobilising capital for green transition.

## Statement of Support to the updated Hong Kong Biodiversity Strategy and Action Plan 2035

BEC has submitted a statement of support following the release of the updated Hong Kong Biodiversity Strategy and Action Plan ("BSAP") 2035, published on 31 December 2025. BEC commends the Government's proactive efforts and commitment to outline its priority actions to safeguard Hong Kong's rich and unique biodiversity and ensure sustainable development in the city over the next decade. Across the BSAP's four priority areas of nature conservation, deepening mainstreaming, capacity building and collaborative partnering, BEC is pleased to see the updated BSAP incorporate several objectives which align with recommendations from BEC's previous submission, alongside other stakeholders' input, and take reference from the latest national targets and international developments.



Some noteworthy commitments include:

- Expanding the network of effectively managed protected areas and exploring the application of Other Effective Area-based Conservation Measures ("OECMs")
- Recognising Hong Kong's ecosystem service values and functions to society
- Encouraging businesses to disclose biodiversity-related risks, dependencies and opportunities
- Increasing capital flows to support nature conservation, green technology and sustainable development
- Incorporating biodiversity considerations into city development policy and decision-making
- Supporting broad adoption of nature-based solutions across the city
- Strengthening capacity building support and resources for local biodiversity and conservation data, research and funding
- Strengthening collaboration and partnerships

## KPMG Executive Forum on Translating COP30 and China's Climate Commitments into Actions

BEC CEO Mr Simon Ng was invited to speak at the KPMG Executive Forum on Translating COP30 and China's Climate Commitments into Actions on 23 January, joining a distinguished panel of industry leaders to reflect on the outcomes of COP30 in Belém and their implications for businesses and financial institutions, with a particular focus on Hong Kong. The conversation revolved around the urgent need to transition from disclosure to tangible implementation in climate action.



Simon emphasised the role of the real economy and noted that many Hong Kong businesses are already taking advanced steps in sustainability ahead of government or regulatory requirements. He believed there is a need to better communicate these success stories to an international audience. He also urged companies to look at upcoming standards like ISSB and the Taskforce on Nature-related Financial Disclosures not just for compliance, but as a gateway to identify risks, develop action plans, and uncover new business opportunities related to nature and biodiversity.





This milestone reaffirms AAHK's long-standing dedication to environmental excellence. Over the years, AAHK has been reducing airport-wide emissions through various initiatives, including adoption of cutting-edge building analytics technology at Terminal 1's air handling units and use of renewable diesel in Ground Services Equipment. AAHK also scaled-up marine ecology and fishery enhancement measures, and embedding green design and sustainable construction considerations in both building and infrastructure projects at the airport through its Green Airport Design and Construction Strategy.




To promote low-carbon living and community resource sharing, **CLP Power Hong Kong Limited ("CLP Power")** has launched Hong Kong's first-ever Electric Appliance Library at the Yau Pok Road Light Public Housing in Yuen Long. This innovative initiative allows residents to borrow energy-efficient household electrical appliances, including cordless cyclone vacuum cleaners, upright garment steamers, inverter intelligent steam microwave ovens and oscillating ceramic heaters. A six-day, five-night “Green Dreams Come True” journey in Sichuan offered the winning students of **HK Electric**’s “Green Energy Dreams Come True” Competition the opportunity to take their green aspirations further. Organised by HK Electric with full support from a Chinese state-owned electric utility corporation, the participants were given exclusive access to several key facilities of the corporation, where they explored smart grid management and innovative technologies. For cultural enrichment, the tour also featured visits to the pioneering Dujiangyan Irrigation System, a marvel of ancient engineering that harmonises with nature and remains relevant to modern sustainability, the Giant Panda Base and the Sanxingdui Museum. These experiences allowed students to gain valuable insights into ecological conservation while immersing themselves in the country’s rich cultural heritage.

With a strong commitment to energy saving and carbon reduction, **Jardine Engineering Corporation** showcased its latest eco-friendly smart display technologies at the recent HKTDC Autumn Lighting Fair. The new ultra-thin, high transparency LED display film enables façades and interiors to become immersive platforms for real time information, digital art, and advertising. The material is lightweight and helps reduce electronic waste compared with traditional display solutions. The team also presented 3D media glass, which delivers high-definition transparent visuals. These innovations support greener buildings and more sustainable interior design.



**Swire Properties**’ White Christmas Street Fair returned to Taikoo Place in December 2025. Designed by university students from the Swire Properties Placemaking Academy, the Fair continued to push towards its zero-waste ambition – achieving a remarkable 96% diversion of event setup materials and consumer waste from landfills. A wide range of circularity measures were introduced, including serving all food and beverages in reusable cups and containers, preventing the disposal of over 13,300 single-use items. The event also utilised 3D printed quartz sand to create decorations that can be broken down and reused, and upcycled decorative traditional neon signs into artwork.

**Towngas** and fellow BEC Member the Hong Kong University of Science and Technology signed an MoU to jointly establish Hong Kong’s first hydrogen energy innovation platform. By leveraging global academic and industry expertise, the two parties will collaborate to drive technology commercialisation and accelerate broader applications of hydrogen energy. Furthermore, a number of hydrogen trial projects led by Towngas have received the green light from the Inter-departmental Working Group on Hydrogen Energy. These include the installation of hydrogen supply facilities at the Tai Po Plant and the deployment of hydrogen power generation at a Central construction site. These initiatives provide significant impetus to the country’s “dual-carbon” strategy and the global transition toward a low-carbon future.

Stanley Liu, Executive Director of **AECOM**'s ports and marine team, joined representatives from the Civil Engineering and Development Department to provide a preview of the Shoreline Management Guideline ("SMG") for Coastal Development. It is the first guideline in Hong Kong to adopt a systematic, risk-based approach to coastal development, providing a structured yet flexible framework to identify and mitigate coastal risks, and to plan resilient, long-term coastal solutions adaptable for both new and existing developments. Stanley drew on his experience in strengthening Hong Kong's coastal defences and highlighted how the SMG will update essential references, including the Port Works Design Manual and Hong Kong Planning Standards and Guidelines.

**CLPe** has launched a new EV charging station at Penny's Bay, Lantau Island, offering fast, reliable and convenient GB/T (China standard) and CCS2 (European standard) charging services around the clock for electric vehicles. Strategically located near the Hong Kong Port of the Hong Kong-Zhuhai-Macao Bridge, this station features amenities including an information centre with a wealth of travel information and drinks vending machines. The facility supports the Hong Kong SAR government's Southbound Travel for Guangdong Vehicles initiative, making cross-boundary journeys smoother for Guangdong vehicles entering Hong Kong's urban areas.

**Great Eagle Group** is harnessing artificial intelligence to drive measurable progress in sustainability and operational excellence across its property and hospitality portfolios. Under the Energy Saving Plan 2030, the implementation of AI-driven chiller plant optimisation at flagship assets, including Great Eagle Centre, Three Garden Road, and The Langham, Hong Kong, has delivered tangible results. By analysing real-time data to predict demand and optimise energy performance, these initiatives have achieved a 6.1% reduction in energy use at Three Garden Road, with full payback realised within six months. This progress advances the Great Eagle Group's ambition to achieve net-zero impact by 2045.



**MTR** has unveiled its Carbon Reduction Roadmap, outlining clear commitments and strategies to reduce greenhouse gas emissions across railway operations, investment properties, and its value chain. The Corporation aims to achieve its science-based decarbonisation targets by 2030 and reach carbon neutrality by 2050, with a focus on reducing energy consumption and enhancing efficiency, electrifying operations, generating renewable energy, and building a low-carbon value chain. As a backbone of low-carbon transportation in Hong Kong, MTR will accelerate its carbon reduction journey through innovation, stakeholder collaboration, and sustainable practices.

**Nan Fung Group** recently hosted Positive Pulse Connect tenant celebration at AIRSIDE, bringing together over 220 tenant representatives and partners to celebrate collective sustainability achievements under its tenant-landlord engagement programme, the Net Positive Lease ("NPL"). In 2025, the NPL reached a significant milestone, with over 100 office, retail, and F&B tenants joining this growing community of sustainability champions. Participation now covers 45% of occupied lettable floor area in Hong Kong and 67% globally, surpassing the 2025 target ahead of schedule. Key highlights include HK\$13.2 million in social value generated, a 6% reduction in energy use intensity, and a 26% waste diversion rate. The event also featured a panel dialogue with tenant representatives who shared practical applications and best practices. The discussion further strengthened partnerships and fostered deeper collaboration across Nan Fung's tenant community.

At the 30·50 FoodSmart Conference & Expo 2025, **ALBA Group Asia** showcased how its reverse vending machine ("RVM") solutions are advancing beverage containers recycling in Hong Kong. The group's latest RVM model now collects plastic bottles and beverage cartons, aligning with the expectation of upcoming Producer Responsibility Scheme. Through its RVM Pilot Scheme project, over 140 million bottles have already been recycled, proving the impact of policy, technology, and industry collaboration. The group also participated in the 30·50 FoodSmart Partnership Programme for driving collective action towards carbon neutrality.

**China Overseas Land & Investment Limited ("COLI")** recently released its Biodiversity Conservation Report, becoming the first mainland real estate enterprise to publish such a report. The report comprehensively showcases the company's achievements in biodiversity management and conservation. Drawing on the four pillars of the Taskforce on Nature-related Financial Disclosures framework – governance, strategy, risk and impact management, and metrics and targets – COLI has established a comprehensive system that integrates biodiversity protection into its ESG management framework, ensuring scientific and orderly progress across all initiatives.



**Dragon Rise New Energy Holdings Limited ("Dragon Rise")** celebrated the opening of its showroom on 24 November 2025, featuring the first battery-swappable EV taxi in Hong Kong. Dragon Rise collaborated with three other leading Chinese energy companies to introduce this cutting-edge taxi model, which marks a "new era of battery-swapping" for green public transportation in Hong Kong. This collaborative effort aims to enhance the cost-effectiveness, time efficiency and service quality of the city's public transportation sector. The initiative allows the public to experience the technological advancements of the Chinese Mainland, while fulfilling its social responsibility through the promotion of development of eco-friendly, green mobility in Hong Kong.

**Dress Green** partnered with a local tertiary institution for the Clothing Sorting & Upcycling Challenge on 4 November 2025. Participants sorted 800 second-hand garments and engaged in interactive workshops on fibre identification and creative upcycling. Through activities like a memory game with bracelets, they learned practical skills to extend the lifespan of clothing. As a token of appreciation, students received eco-gifts, such as upcycled keychains and wallets crafted by people with disabilities. The event emphasised education, sustainable action, and community inclusion, supporting the transition towards a circular fashion economy.



**EcoSage**'s Sustainable Furniture Donation Programme recently delivered a new donation round, turning relocation and renovation surplus into practical upgrades for ageing school campuses. Usable desks, chairs and IT equipment were diverted from landfill to improve staff rooms and teacher work areas, supporting lesson planning, marking and collaboration. The programme also builds a "circular campus" by making reuse visible and meaningful: students and staff see how resources can be renewed, not wasted. Donations are matched to each school's needs; IT equipment is securely wiped to international standards, and non-reusable items are recycled responsibly. With the support from a local charity, EcoSage has benefitted 14 schools and NGOs, donating nearly 500 items in the past three months, advancing SDG 4.

**HK Express** is committed to reducing carbon emissions through fleet modernisation and operational efficiency. In 2025, four A321neo aircraft were added to the fleet, delivering up to 20% greater fuel efficiency per seat than previous models. Green Operating Procedures such as single-engine taxiing and reduced-flap landings have delivered steady fuel savings across 2024-2025. Flight performance tracker and other ground efficiency measures including fixed ground power and pre-conditioned air systems further support carbon reduction by optimising fuel use during flights and minimising consumption while aircraft are on the ground. These efforts highlight HK Express's dedication to advancing sustainable aviation.
