I foresee more collaborations and communications between the Government and the business community via BEC in the coming year.

In 2013, the Government launched "A Clean Air Plan for Hong Kong" in March and "Hong Kong Blueprint for Sustainable Use of Resources 2013-2022" in May. These plans request discussions and exchanges with the community and relevant sectors. To a large extent, the success and effectiveness of their execution depends on the understanding, support and cooperation of the whole community. BEC has a key role to play in engaging the business and the larger community in understanding and responding to these plans and measures, as well as providing society with viable options and sectoral contributions.

In recent months, society has responded actively to some of the major environmental issues of Hong Kong, such as the extension of existing landfills, integrated waste management facilities (i.e. modern waste-to-energy incineration technology), and quantity-based municipal solid waste charging scheme. I hope that the strong network of BEC will continue to help facilitate discussions and contribute expertise to these issues, so that, hand in hand, we can plan for and take effective actions to pave way for a better environment for Hong Kong.



## Message from Chairman

It gives me great pleasure to welcome you to the Business Environment Council (BEC) Anniversary Dinner 2013. Whilst it is the time to review our journey in fostering Hong Kong's environmental sustainability over the last year, it is also an occasion to acknowledge our members and stakeholders' significant contributions to the success in promoting environmental excellence among the business community in Hong Kong.

The past year has been a very exciting one for environmental development in Hong Kong. The HKSAR Government has laid down a few plans and held a few stakeholder engagement workshops to tackle some long-standing environmental issues of Hong Kong, especially with respect to air quality and waste management. BEC prides itself on being able to be involved and contributed in the territory-wide action items under these plans.

BEC, together with Hong Kong Green Building Council, formed the Construction and Demolition (C&D) Waste Joint Working Group to gather views from industry stakeholders and draw consensus for the targets and recommendations on the reduction of C&D waste. Policy recommendations to the Government will be consolidated in the coming months. We are also coordinating BEC Members' views on Hong Kong's environmental policies, and will submit a paper to the Office of the Chief Executive for the Government's consideration in the upcoming Policy Address.

To move Hong Kong towards a low carbon economy, community support and participation, industry involvement and Government's direction are all indispensable. Open dialogues, direct communication and strong collaboration between the Government and the community are keys to the successful implementation of environmental policies and measures. BEC will continue to contribute our ideas to the Government, share our expertise with the community, and provide appropriate communications platforms for the relevant parties. In the coming year, we will continue to gather our ideas and efforts in subjects and issues that are important to environmental sustainability, and of great concern of our Members, to bring about further improvement to the environment of Hong Kong.

I would like to extend my sincere gratitude to BEC Members, partners and the Government for their continuous support to our works in promoting and advocating environmental excellence. We look to further expand our network and exert a greater impact in building a sustainable Hong Kong.

## **Review from Chief Executive Officer**

The past year has been another fruitful and productive year for BEC. Apart from attaining a new high in BEC membership with a 20% increase, we have stepped up our efforts in furthering environmental advocacies on different fronts.

Firstly, 4 Advisory Groups were established for our members during the year, namely BEC ESG Advisory Group, BEC Waste Management Advisory Group, BEC Energy Advisory Group, and BEC Climate Change Business Forum Advisory Group. The mandate of these Advisory Groups is to advise BEC Board and members on matters related to these environmental topics, build capacity amongst BEC members and the broader business community, and forge collaborative links between local and global expertise on these topics. Substantive work plans have been developed for the Advisory Groups for the coming 2 years and we look forward to working with the members of these Advisory Groups in advancing environmental sustainability in Hong Kong.

I am encouraged by the increasing participation of members and the community in our initiatives as well as our events. For instance, participation in our flagship event EnviroSeries Conference this year was over 40% higher than last year. BEC Leadership Networking Series, which is a monthly event introduced last September, has seen an increasing trend in monthly participation. Our new division BEC Institute of Environmental Education started to roll out courses on various environmental subjects and delivered tailor-made in-house training for companies during the year. So far, 13 courses have been held with nearly 400 participants.

Our long-established professional expertise on building energy efficiency and indoor environmental quality continues to contribute to the promotion and enhancement of building environment. In the last 12 months, our teams have assessed indoor air quality for about 750,000 sq m, and provided advice to companies on BEAM Plus projects for nearly 1.5 million sq m gross floor area.

Our involvement in environmental programmes for the community during the year has been equally rewarding. The "BEC Low-carbon School" programme outreached over 6,000 secondary school students in environmental educational activities by means of school talks, company visits, exhibition tours and a dialogue with the Secretary for the Environment. We will work on similar programmes in the coming year. We have been one of the partners for Housing Authority's "Green Delight in Estates" programme since June 2012 and have organised various educational and promotional environmental events for several housing estates. We will continue working with the Housing Authority in this meaningful programme in the coming year.

Furthermore, we have started preparation of Phase 1 of the BEC Headquarters Transformation project with the aim to improve the energy efficiency of the building and to ultimately achieve BEAM Plus Platinum rating. The implementation work will soon start.

The above achievements would not have been possible without the ardent support of BEC members and the Board of Directors, as well as the dedication and diligence of the team of professional staff of BEC. I would like to take this opportunity to gratefully thank all our members, Board Directors and my colleagues for their invaluable contributions. Looking ahead, there are more challenges to come, but I am confident that with the strong membership base and devoted staff, BEC will be able to steer further ahead to attain more fruitful results.
